1 - SPORTING REGULATIONS

CHAPTER I: GENERAL CONDITIONS

Art. 1 - Definition of the Event:

The Magyar Nemzeti Autósport Szövetség (MNASZ) – 1-3, Istvánmezei út – 1146 Budapest with LMEO (Le Mans Endurance Organisation SAS – 103, rue Lamarck – 75018 Paris) will organize the event “**1000Km of the Hungaroring 2010**” which will take place on 21st and 22nd August 2010.
