10. 07. 2025. Publication of Supplementary Regulation and entry application open
27. 07. 2025. Closing date for entries at normal fee
From 28. 07. 2025. Entries at increased fees

Location of the race office: ground floor of the start tower, beside the start grid, opening hours: Friday 10:00-23:00, Saturday from 07:00. Here you can pay the entry fee and receive a schedule and a track map.

Location of administrative checking: ground floor of the start tower, beside the start grid, same as the race office

Location of scrutineering and pass registration: ground floor of the start tower, right side, scrutineering area. Only drivers with a valid entry are eligible for administrative check and scrutineering. Drivers can only attend administrative check and scrutineering in the specified time period for their category.

Access to the official notice board:



For administrative check you can only apply with a valid technical pass.

Administrative check and scrutineering after the scheduled time period is subject to Stewards decison. Drivers below 18 years of age has to attend scrutineering in complete racewear!

The use of quads, motorbikes, electric scooters and electric bikes are prohibited in the paddock and will result in penalty.

Charging an electric car is prohibited on the whole venue.

6. Entry and insurance

The entry application form can be found online at www.chronomoto.hu/offroad. Entries are accepted after the closing date according to the Hungarian RX sporting regulation. Entry fee should be paid to the bank account at Erste Bank 11600006-00000000with credit 72809565 or vou this link card can pay on https://www.rabocsiring.hu/esemeny/4082/matador-rx-night-raceaugusztus-9 or by postal cheque for the next address: RabócsiRing Kft, 4405 Nyíregyháza, Pásztor u. 22. In either case the name of the driver shall be indicated. It is possible to pay the entry fee at the administrative check.

The entry fee for foreign drivers in CEZ categories 300 €, in national categories 195 €.

In case of an entry after the closing date: Double amount will be charged. **The above mentioned prices are including VAT.**

Paddock place request shall be sent to <u>ring@rabocsiring.hu</u>. Paddock plan will be made in this consideration and according to category priotities.



Timing

Timekeeping of the competition will be made with transponder. The use of transponder is mandatory for every driver. Transponder rental will be available at the Administrative check for 5 000 HUF.

Entry pass

The Organizer provides 5 passes (1 driver + 4 crew) / entry and 1 paddock car pass which will be given at the entrance upon arrival.

Additional tickets are available for Teams on discounted price. Please contact the Organizer about your request by phone or email.

Parking in the paddock is limited, therefore it is not allowed without a car pass! You can park your car in the parking in front of the main entrance. Trailers shall be taken into the trailer park.

Insurance

Every driver must have drivers' insurance. The entry fee is including an insurance that is covering competitors for Civil Responsibility towards third parties. The insurance is valid from start of the event till the end of the event or at the time of disqualification from the event if applicable.

7. Prizes

According to Rallycross sporting regulation. Prize-giving ceremony will take place next to the Race control tower.

8. Reservation of a right and Competitors' Responsibility

The Organizer reserves the right to modify the supplementary regulation up until the start of the event, under the following conditions: in case of any change drivers will be informed by dated and numbered bulletins approved by the Off-road Committee. From the beginning of the event, this right falls under the authority of the Stewards. By signing the entry form, participants agree to comply with the provisions of the supplementary regulations and its bulletins. Participation in the event is at the competitors' own risk. By signing and/or submitting the entry form, competitors declare that they will not make any claims for damages against the organizer and hereby waive any right to compensation.

9. Environmental Protection

Each competitor must have a plastic sheet of at least 4x5 meters at the designated team area where work on the vehicle is carried out, in order to prevent any contamination caused by potential leaks. Additionally, a 150-liter garbage bag must be available for waste collection. All work on the vehicle may only be carried out on this plastic sheet.

10. Safety regulation

Each competitor must place a functioning fire extinguisher with a minimum charge of 5 kilograms within their own paddock area. No other work may be carried out on the vehicle during refueling.



Only drivers with a valid entry are eligible for the Administrative checking and Scrutineering. Drivers must arrive for the checks strictly within the time slot allocated to their category.

Administrative checking

A valid driver and competitor license must be presented. The location for the administrative check is the race office.

Scrutineering

All car taking part in the competition must be presented to scrutineering (Scrutineering Bay) Any car arriving after the closure of scrutineering may be refused permission to start. Noise level: The maximum noise level for all cars is 100 dB, measured using a sound level meter with an "A" filter setting in SLOW mode. The microphone must be positioned at a 45° angle, 50 cm away from the exhaust outlet. During the measurement, the engine must be running at 4500 rpm.

The use of tire warmers or heating devices is strictly prohibited for both dry and wet tires.

Technical scrutineering will take place either in the scrutineering bay or at the competitors' paddock place.

Drivers under the age of 18 must attend scrutineering wearing full racing gear.

12. Running of the event

Practice: A maximum of 8 cars may be on the track simultaneously during official practice sessions. Each driver must complete at least one timed lap during the practice. Failure to do so is subject to Stewards decision whether the driver may participate in the race.

At the qualifying heats the number of cars is 5, at the semi-finals and finals the number of cars is 6.

The following categories may race together, but their final results must be classified separately::

- SuperTouringCars -1600, SuperTouringCars -2000 and SuperTouringCars +2000



Races in the RNOB and CEZ categories will include a Joker Lap.

13. Parc Fermé - Results - Protests

Parc Fermé

All drivers who completed or were disqualified from the finals must drive their cars directly to the Parc Fermé area and the cars shall remain in the Parc Fermé for at least 30 minutes after the publication of the results. The release of the Parc Fermé is decided by the stewards. No repairs or refueling of the vehicles is permitted within this area.

Results

All results will be published on the Official Notice Board.



Protests – appeals:

The right to file a protest is reserved for the competitor. Protests must be submitted in accordance with the relevant articles of the FIA International Sporting Code. If the protest is deemed unfounded, the protest fee, in whole or in part, may be retained.

Protest fee: 300 000 HUF

In the case of a technical protest requiring disassembly, the stewards—based on the recommendation of the technical delegate—may impose an additional disassembly deposit on top of the protest fee. If the protest is unfounded, the cost of disassembly will also be payed by the protesting party.

The competitor has the right to request a review and file an appeal against certain decisions of the Stewards, in accordance with the applicable deadlines and rules of the FIA International Sporting Code.

Appeal fee: 200 000 HUF
