3. Description of Circuit

Place: SENICA - DOLNÉ SUROVINY

Length of circuit: 800 m

Width of start: 16 m

Max. width: 24m

Min. width: 12 m

Location: The route from Senica town – direction Jablonica cca 800m taking the first turn right on the gravel road (400 m)

5. Registration

5.1 Each driver who wants to take part on the competition has to send filled-in registration until 28. 07. 2012 to

23.59 to secretariat: c.a. Autocross 3R Prietrž, No. 78, 906 11 Prietrž, or fill-in an online registration at: www.prihlaska-sams.sk (MOGUL autocross Senica) – It is necessary to bring printed-out registration form to check during administrative acceptance of drivers.

6. Starting Fee

Starting fee: 100 €, raised starting fee: 150 €

Starting fee for SAP: 40 €

Starting fee and charges are to be paid during administrative acceptance of drivers.

A competitor who will refuse a compulsory advertisement will be charged 120 €

7. Insurance

Competition is signed in the calendary of SAMŠ and is insured against damages caused by third party.

IV. ACCEPTANCE PERIOD

9. Administrative Acceptance

All drivers have to take part on the administrative acceptance held on 04/08/2012

(Saturday) at a secretariat from 08:30 to 11:30 (in accordance with the time schedule)

All drivers have to show all necessary documents for the year 2012 racing competitions.

10. Technical Acceptance

10.1 Each car taking part on the race has to undergo technical acceptance which will be held on 04/08/2012 (Saturday) from 07:45 to 10:45

10.2 Each car which will be considered as inappropriate due to safety regulations of FIA (supplement "J") in competitions CEZ, MSR and SAP, cannot take part on these competitions.

V. RACE COUSRE

12. Trainings

There will be organized one free training for the cars for an hour. There will be two measured trainings. In each training there will be maximally 6 cars for three laps. For divisions SAP H1, H2, H6 there will be organised one measured training according to Ročenky 2012 point 8.3.1.

from the start of the first car on the track. Each driver is obligated to take part on the measured training. The start will be realized by a flag with individual start.

14. Qualification

There will be organized 3 series of qualification races. Each set will last 4 laps.

The drivers who will get less than 21 points in the two measured laps will be able to qualify themselves for the final start.

The start of qualification laps will be realized by green light or a flag.

15. Final

Each of the finals will last 6 laps. The start of finals will be realized by green light or a flag.

VI. CLOSED PARKING LOT - RESLULTS - PROTESTS

16. Closed parking lot

All cars which will finish the finals will be placed to the official closed parking lot where must remain at least 30 minutes after publication of results of the race. In this parking lot it is prohibited to make any repairs on the cars or to fill fuel.

19. Results

Results of each race will be showed immediately afterwards. Final races will be exhibited on the official notice-board before the beginning of the final races. The final qualification will be completed from achieved ranks in the final races. All results will be shown on the official notice-board.

20. Protests and appeals

Each protest must be claimed according to MŠP, it has to be in a written form and delivered to the director of the race or second-in-command or to the sports commissary if they are not available with fixed fee.

VII. PRIZES AND CUPS

21. Prizes

21.1 Closing ceremony is to be held immediately after the final round finishes. Each driver in person has to take part on the closing ceremony in proper racing clothes.

21.2. Rewards

Drivers who will achieve one of the first three places will be rewarded by material prizes, prize money will not be paid.

21.3. Prizes and cups

Handovering of the prizes will come after the end of the last final race.

IX. ADDITIONAL INFORMATION

22. Fire Extinguishers

Each driver has to have a prominently displayed fire extinguisher in the parking lot of race cars with minimal amount of 5kg.

Each driver has to have a foil under the vehicle with dimensions at least 4x5 m, at which he/she can repair the damages on the vehicle to prevent pollution of the environment by oil or other dangerous liquids.

24. Manager for contact with drivers

Manager for contact with drivers is Mr. Mgr. Mikuláš Fajnor, who will be available all the time of the race in the premises of parking lot of the race cars, at the entrance to the track, in the place of start and will take part on the meeting of RŠK.

The manager will have an orange vest and his photography and places of operation will be shown on the official notice-board.
