Art. 4. Entries

Entries must be submitted in accordance with the FIA CCRSR Art. 16 – Art. 18.

An entry application will be accepted only if accompanied by the total entry fees. The entry fee must be credited in full to the organiser's bank account.

According to the FIA International Sporting Code, foreign competitors/drivers must have their ASN's permission, which should be attached to the entry form (ASN's stamp on the entry, or the ASN's written permission to take part in the competition, or the licences copies with the described permissions in them)

Art. 4.3 Number of competitors accepted and vehicle classes

Art. 4.3.1 The number of competitors shall be limited to: *maximum 60 of cars*

The minimum number of entered cars required is.: *30 of cars*

"If that number is not reached, the Organiser may cancel the competition after obtaining the FIA's approval."

Art. 4.3.2 Eligible cars

- **Group T1:** Prototype Cross-Country Cars, complying with Appendix J Article 285.
- **Group T2:** Series Production Cross-Country Cars, complying with Appendix J Article 284. Vehicles must also comply with Appendix IV of FIA CCRSR.
- **Group T3:** Lightweight Prototype Cross-Country Vehicles, complying with Appendix J Art. 286.
- **Group T4:** Modified Production Cross-Country Side-by-Side Vehicles, complying with Appendix J Article 286A.

Art. 4.5 Payment

Any entry which is not accompanied with the entry fee will be considered as a preliminary one.

Art. 4.6 Entry fee refunds

The entry fee shall be refunded in full

- if the event does not take place
- to teams whose entry application is rejected

The organiser may partially refund entry fees, if a competitor cannot take part in the event due to a duly proved case of force majeure.

The deduction will be:

- 50% of the entry fee for the requests received until 20 days before the administrative checks.
- 100% of the entry fee for the requests received less than 19 days before the administrative checks.

Art. 5. Insurance Cover

Insurance will be done in accordance with Art. 15 of the 2022 FIA CCRSR.

Name of the insurance company: SRC SPECIAL RISK CONSORTIUM GMBH, Kuniberts kloster 7-9, D 50668 KÖLN.

The limit of the responsibility is 3.000.000 Eur.

- In case of an accident leading to insurance event, the competitor or his representative must make a written statement to the Clerk of the Course, the Competitors Relations Officer, or directly to the Organizer, within 24 hours. This statement must mention the accident circumstances, the names and addresses of the casualties, as well as contact details of the witnesses.
- Competitors are reminded that only damage caused by the organizers and named drivers are covered by the Organization's insurance policy. Loss or injury that may be suffered by the drivers themselves or participating vehicles is EXCLUDED.
- Irrespective of this Third Party insurance, entrants and drivers are free to take out the policies they deem fit on their own account and at their own discretion.
- Service vehicles, including those displaying the plates supplied by the Organization, shall under no circumstances be deemed participating vehicles. They are therefore not covered by the Organization's insurance policy and responsibility for them lies solely with their owners.
- The insurance cover will come into effect from the administrative checking and scrutineering for the Event and end upon the expiry of one of the following time limits, whichever is the later:
 - time limit for protests or appeals or the end of any hearing by the Stewards;
 - end of the administrative checking and postevent scrutineering;
 - end of the prize-giving.

The Organization refuses all responsibility stemming from the consequences of infractions of the law, regulations and decrees of Hungary, committed by Competitors or their service crew, which must be exclusively borne by them.

Art. 6. Advertising and Identification

Art. 6.1 Obligatory organiser's advertising

The organiser will provide each crew with the number identification (67x22cm), which must be affixed to their car in the stated positions prior to scrutineering. Each panel shall be placed horizontally at the leading edge of each front door, with the number at the front. The top of the plate shall be between 7 cm and 10 cm below the lower limit of the window. **It is not allowed to cut the panel.**

Art. 8. Fuel

Refuelling is permitted only in commercial fuel stations using fuel on sale to the public. Only the crew may carry out this procedure. Refuelling stations authorised will be indicated in the Road Book with "FUEL STATION".

All type of fuel must follow Appendix J Art. 252.9. (Art. 57 of the FIA CCRSR).

The use of the fuel quick couplings (Stäubli SPT12 type) is mandatory for T3 and T4 group vehicles, according to the art. 57.2.1 of the 2022 CCR SR.

Art. 9. Administrative checks

Before Administrative Check, each vehicle must **Register** at Suzuki Mészáros, Grábler Tó str.10, where the Checklist and Service Plates will be provided.

Art. 9.1 Documents to be presented:

To minimize the time required for administrative check, please make a photo or scan copies of the documents required, and send them to the following email address: julianna@hungarianbaja.com. Make sure to bring and present the following documents:

- Competitors' licence
- Driver's and co-driver's competition licences
- Driver's and co-driver's ID cards/passports
- Driver's and co-driver's valid driving licences valid for the vehicle entered
- ASN authorisation for foreign competitors (if required)
- Completion of all details on the entry form
- Car registration papers
- Car insurance cover
- FIA Technical Passport (or ASO Technical Passport)
- FIA Homologation form for T2 vehicles
- Authorization from the owner (if not the driver)

Art. 9.2 Timetable

See programme (SR Art. 3)

The following additional procedures will apply:

- Administrative checks should, whenever possible, be carried out together with the collection of rally materials and documents.
- Notwithstanding Art. 22.1 of FIA CCR SR, drivers and co-drivers are not required to report personally to the administrative checks. Each Competitor shall nominate in advance to the Rally Organizer one authorized representative to complete administrative checks and collect the rally materials and documents, provided in plastic bags. In order to receive the package, administrative checks must be fully completed.

The original documents required for the Administrative Check must be presented for visual inspection.

Individual times for administrative checks will be published for each competitor in 'Organizer's communication' and published on the website: www.hungarianbaja.com, and Sportity

A time control before the Administrative Checks (C1) will be arranged, according to the individualized timetable.

Any delay to the C1 control will be penalized as follows:

- From 1 to 15 minutes: 150€ fine

- From 16 to 30 minutes: 250€ fine
- From 31 to 60 minutes: 500€ fine
- More than 60 minutes: 500€ fine and report to the Stewards.

Art. 10. Scrutineering, Sealing and Marking

Art. 10.2 Mud flaps

According Art. 25.3.4 of the FIA CCRSR, the use of mud flaps in compliance with the Art 283-19 is compulsory.

Art. 10.3 Drivers' safety equipment

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g. HANS devices, must be presented for scrutineering. They shall be checked for compliance with Appendix L, Chapter III. In compliance with Art.48.1.and Appendix III of 2022 FIA CCRSR the medical kit and survival kit (the medical kit must come from the FIA technical list No. 83.) are mandatory.

Art. 10.4 Special national requirements

According the hungarian traffic rules, using headlight is compulsory on the road sections and in selective sections too.

Art. 10.5 Installation of the Safety Tracking System

Art. 10.5.1 Tracking System

All vehicles must **only** be fitted with the Safety Tracking System(s) provided by the Organiser. The instruction for the use of the Tracking System is in the Appendix 5 of these Supplementary Regulations. The system will be collected either by the crew or a representative and must be installed before the car is brought to scrutineering. All the damage caused for the rally safety tracking equipment will be invoiced afterwards.

Art. 10.5.2 Navigation System (NAV-GPS)

Competitors are obliged to be equipped with one or two Navigation System(s) (NAV-GPS) downloaded with

the waypoints given by the Organiser. When a crew uses two NAV-GPS, it must indicate in writing, at scrutineering, which of the two will be considered as the official one.

Regulations regarding the use and installation of a NAV-GPS; Appendix 5 and 6

Art. 10.5.3 Connection of the Systems (FIA CCRSR Art. 12.3)

The specifications for the standard power connector are laid down in the FIA CCRSR Appendix VI.

It is the competitor's responsibility to ensure that the Safety Tracking System(s) and the NAV-GPS always remain permanently connected and switched on with the antenna connected throughout the duration of the competition.

Art. 11.9 Electronic start procedure at the start of a Selective Section

The start of the selective section is happening based on an electric clock and lamp, connected to a false start alert system.

When the car arrives at the start line, the front of the car should be positioned behind a stick placed by the marshal to define the exact start position. One minute before the start time, but not before the car has stopped in its exact position, the marshal shall remove the stick and the crew shall refer to the automatic countdown clock. Any subsequent change of the car's position until its start time is not permitted and will be reported to the Stewards.

Art. 11.10 Service

Art. 11.10.1 Service Areas / Bivouacs

Access to the service park will only be permitted for vehicles, identified by the Organizer, showing the Service Plates, provided by the Organizer at the Registration. Accompanying team cars can enter only by purchasing a 200€ sticker at the Administrative Checks(1 service plate/team is provided by the organizer).

Tampering with or falsification of these plates will lead to disqualification of the team to which these service vehicles belong, on the decision of the Stewards. Plates will be placed in a visible area inside of the front windscreen of the vehicle.

Work on a competing car will be permitted only at service areas specified by the Organization.

Number of team members working in the Service Park and their identification are in accordance with V2-Art. 50.2.4. of the 2022 FIA CCRSR.

They must wear the armbands provided by the Organizer at ADMINISTRATIVE CHECK.

Car wash and Refuelling is strongly prohibited in the total area of the service park!!! Only possibility to wash the cars on the side of Service Park by yourself in the official car wash company.

The maximum speed allowed in the service park is 30 km/h in accordance with Art.51.3.of the 2022 FIA CCRSR. In case of a violation of this regulation by any vehicle/team member related to a competitor, the competitor will be penalized with 10 seconds per km/h over the speed limit.



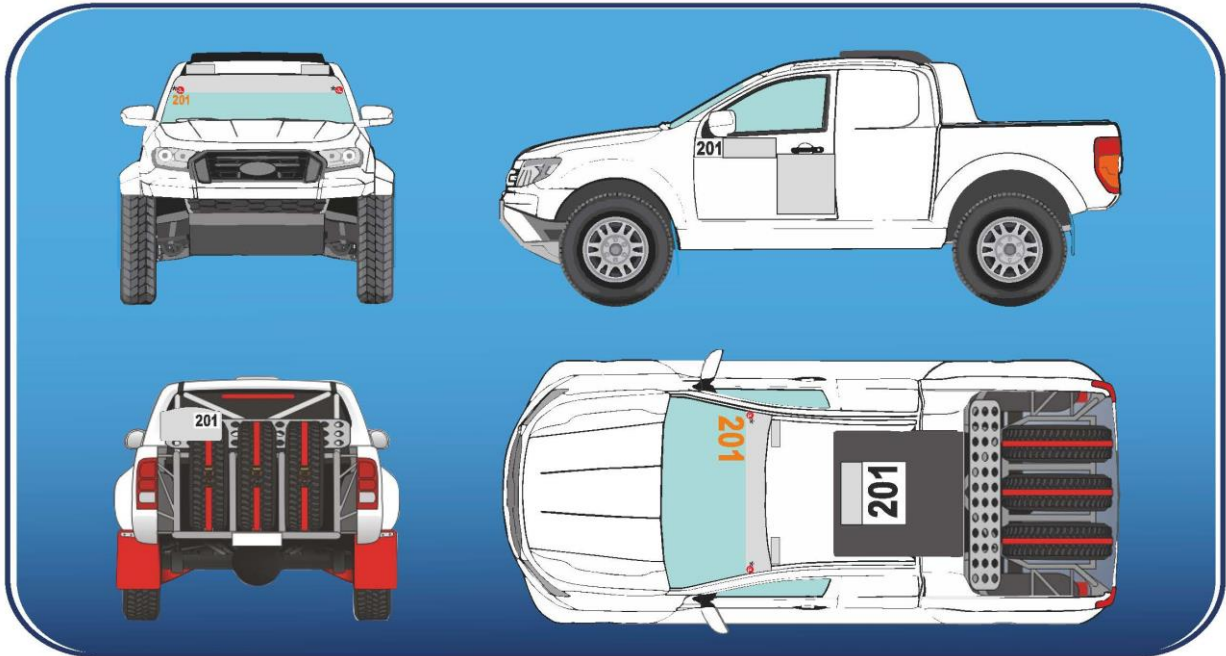

Appendix 4 – Extracts from FIA ISC Appendix L relating to overalls, helmets and any other safety requirements

All competitors are reminded of Appendix L of the FIA International Sporting Code, in particular its Chapter III - Drivers' Equipment.

Helmets (Appendix L, Chapter III, Art. 1)

All crews must wear crash helmets homologated to one of the following FIA standards listed in Appendix L.

Frontal Head Restraint (FHR, Appendix L, Chapter III, Art. 3)

All crews must use FIA approved FHR systems homologated to FIA standard 8858.

Approved FHRs, anchorages and tethers are listed in Technical List N° 29.

See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

Flame-resistant clothing (Appendix L, Chapter III, Art. 2)

All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2000 standard (Technical List N°27) or 8856-2018 (Technical List N° 74). Please pay special attention to the prescriptions of Art. 2 concerning embroidery and printing on flame-resistant clothing (manufacturer certificates etc.) **as well as concerning the correct wearing of the clothing elements! See also FIA Cross-Country Rally Sporting Regulations Article 48.1.**

Biometric Devices (Appendix L, Chapter III, Art. 2.1)

Drivers may wear a device to collect biometric data during racing.

- If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.
- If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.

Wearing of jewellery (Appendix L, Chapter III, Art. 5)

The wearing of jewellery in the form of body piercing or metal neck chains is prohibited during the competition and may therefore be checked before the start.

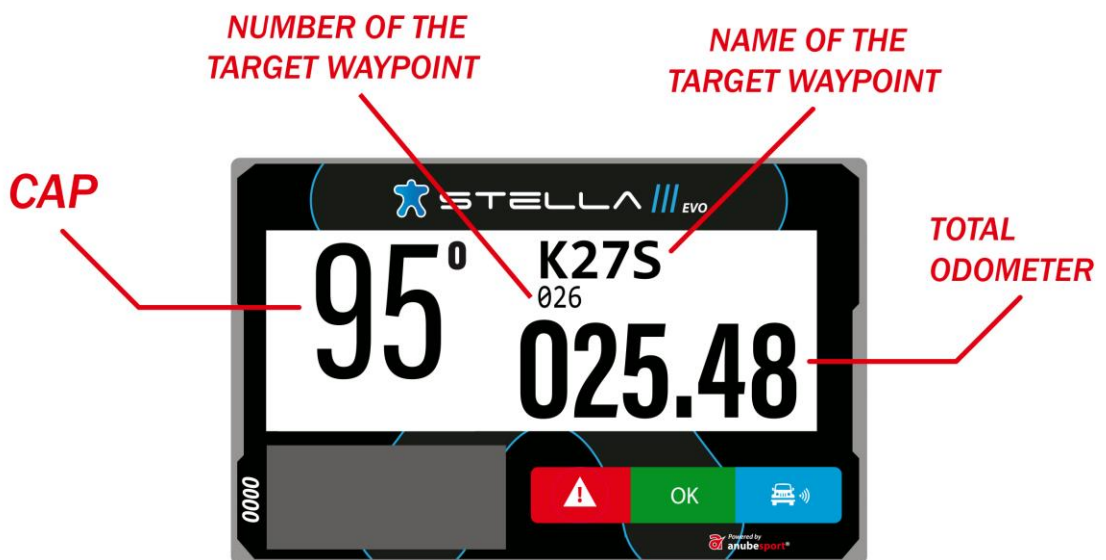

Kit components and Instructions for the use of the car-to-car communication system

KIT COMPONENTS

1. Iridium Antenna
2. Power Cord
3. RF Cord
4. RF Antenna
5. Base/Mount
6. GPS Antenna
7. Adhesive
8. Straps

IMPORTANT

For the functional tests and verification, all vehicles must have gone through the installation of the mount, power cord, and antennas.

The radio-frequency antenna must be installed vertically to the roll cage bars (cars and SSV) and the forks (ATV). It is mandatory to use separators (included in the kit) to avoid contact with metallic parts and the carbon fibre that surrounds it. Once the antennas are mounted, take the SMA connection cords to the base/mount where the STELLA III EVO will be installed.

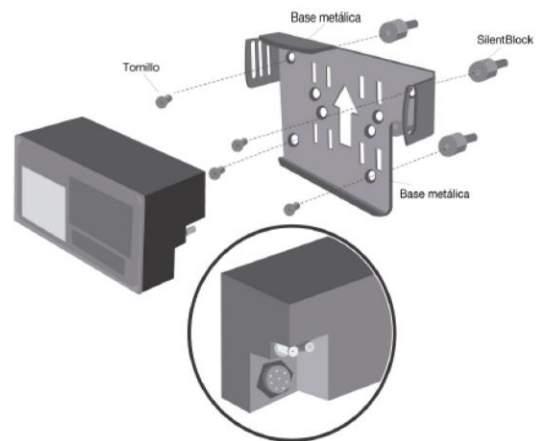
1. POWER CORD

- Connect the red wire to the positive end of the battery 12V(+), and the grey wire to the negative end (GRD). The power cord must be connected directly to the battery (without interruptions and without contact in the power supply).
- A 3A fuse (not included) should be connected to the red wire.
- Take the cord to the location in which the STELLA III EVO is to be installed. All other wires must be insulated, they cannot touch.



2. BASE/MOUNT

- Motorcycles and ATV: The mount can be attached to the handle bar or to a metal plaque close to the navigation system.
- Cars and UTV: The mount can be attached to the panel, or to the roll cage bars. STELLA III EVO buttons must be visible and accessible to the participant (pilot/navigator) even when they are sitting and with the seatbelts buckled.



IMPORTANT

Leave the cords (antenna and battery) in place with at least 10 cm to spare for easy handling.
At least 5 cm of space behind the mount (bottom right corner) to allow space for power cord/connections.

3. GPS ANTENNA

The GPS antenna must be installed horizontally and without obstructions toward the sky. In cars and UTV, It can be mounted on the roof, the hood, or the dashboard. In motorcycles and ATV, attach to the mudguard. For additional firmness, it is recommended to cover it with adhesive tape (non metallic when mounting it to a metallic surface) and pull-up (when attached to soft or plastic parts).



4. ANTENNA IRIDIUM

The Iridium antenna must be installed horizontally and without obstructions toward the sky. In cars and UTV, It can be mounted on the roof, the hood, or the dashboard. In motorcycles and ATV, attach to the mudguard. For additional firmness, it is recommended to cover it with adhesive tape (non metallic when mounting it to a metallic surface) and pull-up (when attached to soft or plastic parts).



5. RF ANTENNA
